We would like to ask to submit a price offer for supply of a production mashine constisting of a rotary module with laser and a flat die module for the production of Pakom Sp. z o.o.

I. Description of the subject of the contract

The subject of the contract is a production machine consisting of:

- A rotary module, laser cutting,
- A flat die module.

The orderer assigns the surface to the foundation of the machine:

• In the technological flow (maximum 5m long, 2.5m wide)

Or

• In two separate modules (maximum 5m long, 2.5m wide each)

Technical parameters that the ordered machine must meet.

Ad 1) Regarding the rotary module with laser cutting:

- web width min. 330mm,
- laser cutting station with maximum cutting area of at least 330 x 330mm,
- speed regulation in the range from 0 to 50 m/min,
- an encoder for controlling the exact feed of the raw material,
- sensor/sensors for detecting printed of pre-cut materials,
- CO2 laser power of at least 350W,
- 3 axis scan head providing maximum diameter of the spot of the laser cutting of 0,3mm,
- the machine should provide the possibility to cut in start/stop, continuous and tracking mode,

- electronic speed regulation in range from 20 to 100 strokes per minute,

- Submission of partial and/or variant offers is not allowed
- In case of any doubts related to the offer presented, the Ordering Party reserves the right to request the Bidder to submit explanations or supplement the offer.
